

Welcome to Wye Marsh Summer Camp!

At Wye Marsh Camp, campers will have endless opportunities to *escape, explore, and experience* nature through experiential play and investigation. Campers will learn about reptiles and raptors through interactive live animal demonstrations; explore over 25km of wilderness trails; voyage our marsh channels by canoe; investigate wetland habitats through dip netting; test their archery skills; create nature-themed works of art and much, much more! Each week has a different nature theme with associated special activities, giving campers a chance to examine more closely some of what the Marsh has to offer.

Frequently Asked Questions

1. What time does camp start?

Camp runs from 9:00am - 4:00pm. If you have registered for early and/or late care, your camper(s) are to be dropped off no earlier than 8:30am and to be picked up no later than 5:00pm.

2. What is Covid-19 precautions in place?

The safety of campers, visitors, staff and volunteers is top priority for Wye Marsh. We are taking every precaution to ensure the best, and safest, experience possible. In addition to regular health and safety measures, Wye Marsh Wildlife Centre is following the Ontario Government, Simcoe Muskoka Health Unit and Ontario Camp Association (OCA) COVID-19 provisions. This includes pre-screening for all campers, hand wash stations, cohorts of 6-10 campers, temperature checks daily of all campers, social distancing of 6-feet, masks worn inside or when social distancing is unattainable, as well as strict cleaning protocols in between activities.

3. What is the arrival/departure procedure?

For your camper's safety, s/he must be signed in and out of camp each day with a signature from a pre-approved guardian. Every camper must also do a pre-screening and have their temperature taken before they may enter. Our sign in/out table is at the Pavilion, which is located at the far end of the parking lot as you drive into the Wye Marsh. Your patience is appreciated during this process.

4. What if someone that is not on the registration form's authorized pick-up list needs to pick up my camper?

Any last minute additions needed to be made to the authorized pick-up list must be made in person during the morning sign-in procedures (at the latest). We cannot accept authorization via the telephone/email.

5. What is the cancellation policy?

We require 7 days' notice for all cancellations. Please note that all cancellations are subject to a \$20 administration fee. For any last minute absences or late arrivals kindly call the centre at your earliest convenience - 705-526-7809 x200.

My camper has special needs. How will you ensure that your programming remains inclusive?

6. Please contact the Camp Director at 705-526-7809 to discuss the best way to care for your child. Wye Marsh Day Camps strive to be as inclusive as possible and abides to the Accessibility for Ontarians with Disabilities Act (AODA), but will need to assess each case on an individual basis to ensure quality care and quality programming. Typically, if your child requires one-on-one assistance in their classroom environment, we will also require the same arrangement.

7. Is there food available for purchase on site?

There is no food available on the site at this time.

Health & Safety

- Wye Marsh Day Camps are **nut/peanut-sensitive**.
Wye Marsh Wildlife Centre is open to the public during day camp hours (9am-5pm). Due to the public nature of the facility, Wye Marsh Day Camps are not able to ensure a nut/peanut-free environment. We do however, remain peanut-sensitive and require that campers do not bring products containing nuts/peanuts to camp.
- Wye Marsh Day Camps and **Sabrina's Law**.
Anaphylaxis is a growing concern among schools and camps. If your camper carries an Epi-pen for their allergy they must carry it with them at all times. Please ensure that the Camp Director is aware of your camper's condition.
- Wye Marsh Day Camp is an **outdoor** camp.
Please ensure that your camper comes prepared with clothing and footwear suitable for being active in the outdoors. *Please see "What to Bring" list for more details.*
- Our policy specifies that counsellors **will not apply sunscreen** to your camper.
Please ensure that you apply sunscreen to your camper before their arrival at camp. Our counsellors will make every effort to remind your camper to apply sunscreen throughout the day, but teaching your camper about sun safety is the best protection.

What to Bring

Please include LABELS on all of the following recommended items:

- √ Hat
- √ Sunscreen
- √ Insect repellent
- √ Close-toed shoes
- √ Change of clothes
- √ Raingear
- √ **Peanut-free** and **litter-less** lunch with snacks
- √ Refillable water bottle
- √ Medications with instructions
- √ Mask
- √ Something to hold mask when not in use (Eg. Paper bag)

Please Do NOT Bring:

- Money
- Valuables
- Toys
- Electronic devices (iPods, cell phones, tablets, video games etc.)

Camper Commitment

It is the goal of the Wye Marsh Day Camps to provide a fun, safe, and secure environment for all participants. Each camper is expected to commit to the following guidelines in order to ensure that our programs run smoothly.

Please ensure that you have reviewed the following with your camper(s).

Camper Commitment

As a camper I commit to:

- Respecting myself
- Respecting others
- Respecting the environment
- Respecting the facilities

Possession or use of alcohol, tobacco, or drugs are strictly prohibited.

Disrespectful Behaviours

- Endangering the health and safety of peers, staff/volunteers and/or wildlife.
- Stealing or damaging other's personal property.
- Damaging natural things and/or disturbing wildlife and their habitats.
- Leaving the program without permission.
- Continuing to disrupt the program.
- Refusing to follow the behaviour guidelines and rules.
- Using profanity, vulgarity, or obscenities.

Any form of bullying or harassment will not be tolerated.

Consequence Sequence

1. Staff directs the camper to more appropriate behaviour. The camper is reminded of the behaviour guidelines and rules, and a discussion will take place.
2. If the inappropriate behaviour continues staff documents the situation. This written documentation will outline what the inappropriate behaviour was, what provoked the situation, and the corrective action taken. Staff notifies the Camp Coordinator of the situation, who then discusses the situation with the camper.
3. If the inappropriate behaviour continues the Camp Director discusses the situation with the parent/guardian to come up with a plan to manage the inappropriate behaviour. If the inappropriate behaviour continues to disrupt the program, suspension may result. Expulsion from the program will be considered in extreme situation.
